- Compliance of RTE Act 2009 Section 12(1) (c) from academic year 2022-23 to extent of seats as prescribed under the Act.
- The school has to teach Kannada as a First language/Second language as the case may be.
- The school being governed by Government of Karnataka regulations for safety and security of students issued from time to time.
- The Management/School should submit/comply with CBSE board affiliation norms and submit all the records and credentials accordingly.
